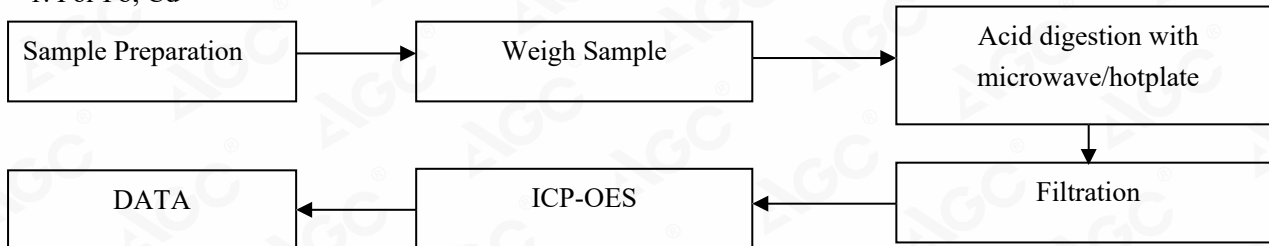

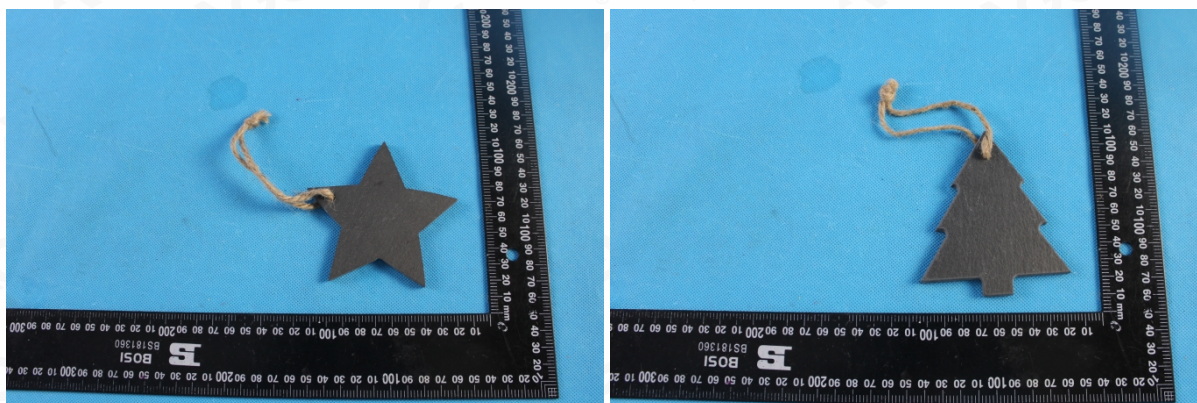


Test Flow Chart
